No need to make a special trip to a branch or ATM to deposit a check. With Remote Deposit from Southeast Financial, you can deposit checks directly into your checking or savings account using your phone or tablet.

To get started using Remote Deposit, log in to Online Banking and select Remote Deposit under the Additional Services menu. Once you've read and accepted the End User Agreement, watch your email for information on your enrollment status.

How to deposit a check

1. Endorse the back of the check with the following information:
 - Member Signature
 - Account Number
 - "Via Remote Deposit"
 - On Date (in mm/dd/yyyy format)
2. Open and log in to the mobile app.
3. From the menu, select Check Deposit.
4. Select the deposit account and enter the check amount.
5. Take a picture of the front and back of the check.
6. Verify the photos and information, then click Deposit.
