don't fall victim to a scam

tips for insurance open enrollment and holiday giving

While you're busy hanging lights and tossing tinsel this year, scammers are looking for ways to catch you off guard. Watching for common scams can help keep you and your money safe and put scammers on the naughty list this season.

Health insurance scams

You get a call offering you a big discount on health insurance. Or someone contacts you claiming to be from the government and asks for your Medicare number to issue you a new card.

Medicare open enrollment season is also open season for criminals. When health insurance is a big story, scammers get busy contacting people. They may try to get your social security number, financial information, or account number.

Ask yourself these questions. Is that insurance plan a good deal? Is that "government official" really from the government? Do you need a new health insurance card? The answer is almost always "no". If you get a call that raises questions, here's what to do:

Stop. Check it out. Before you share your information, call Medicare (1-800-MEDICARE). Do some research, and check with someone you trust.

Pass this information on to a friend. Talk to your friends and discuss the latest scams you may have

heard about. Communication about common threats can help keep you one step ahead of the scammers.

Don't fall for the call

Imagine you pick up the phone and hear a recorded message, robocall, or a live person selling something. Maybe it's not who your caller ID said it was. It's frustrating, and you just want it to stop.

Recorded sales calls are illegal unless you give a business written permission to robocall you. If your number is on the Do Not Call Registry, you're not supposed to get any sales calls — live or recorded. But scammers ignore the rules about when and how they can call you.

Scammers can use technology to make their calls look like they come from anywhere: the IRS, a business you know, a neighbor, or even your own number. Because phone numbers can be faked, you can't trust your caller ID. So now what?

Hang up. Don't press a number. Just hang up the phone on unwanted calls. Consider call-blocking services to reduce the number of unwanted calls you get. Ask your phone carrier about call blocking and read expert reviews about your options. Learn more at ftc.gov/calls.
